- D. Guest Speaker Guest Speaker: Brian Rowley, P.E. Caltrans District 4 Overview of Caltrans Partnerships with Outside Agencies
 - Caltrans as a developer recognizes that their activities are part of the overall problem concerning watershed health. Caltrans projects increase pervious surfaces, increase runoff, increase erosion potential, and discharge roadway/vehicular pollutants into waterways. As such, Caltrans has a dedicated environmental division which assesses and responds to water quality impacts.
 - Within the state and federal regulatory framework, Caltrans achieves water quality compliance with both on- and off-site mitigation efforts. Off-site mitigation is becoming more common.
 - Caltrans has partnered with Sonoma County and the City of Santa Rosa to complete three off-site mitigation projects:
 - Sonoma County Fairgrounds (Brookwood Parking Lot)

 - Patrick Givone (Windsor) supports the drought theme for the event as landscape irrigation makes up a large percentage of residential water use.

- Drought update
 - o Bob Cox (Cloverdale) said that two ordinances mandating a 25% water use reduction passed in February 2014. Since the reduction mandate, residents have reduced their use by 35%. Healdsburg and Cloverdale made national news as two cities that may run out of water within 6 weeks. Bob Cox believes that may have contributed to the large-scale cut backs in residential water use.
 - Mary Ann Landis added that Ukiah is seeing very successful results from voluntary conservation efforts, with water reduction estimated at 50%.
