3. 2015-2016 Work Plan Wrap Up

- Project updates
 - Spanish Urban Creek Care Guides have been printed and distributed to member agencies. PDFs of both the English and Spanish-language versions are available on the RRWA website.
 - Safe Medicine Disposal Program
 - Sonoma County Ordinance Collaborative has made progress in the ordinance development process. FAQs and Talking points have been developed for elected officials and senior staff.
 - The regional take-back program reached a milestone of collecting 100,000 lbs.
 - The program's website (safemedicinedisposal.org) has been updated.
 - o Stormwater Program
 - Prop 1 SWRP & R3MP application was submitted on behalf of member agencies. Further discussion later in the meeting.
 - Annual Stormwater Activities Technical Memorandum will be distributed to member agencies by mid-August for inclusion in each agency's stormwater annual report.
 - Website and Social Media Campaign update

4. 2016-2017 Work Plan Kick Off

- Russian River-Friendly Landscape Program
 - Subcommittee efforts have begun for planning of an event for landscape professionals in January 2017, development of a "mini-guide" in Spanish, and development of a homeowner brochure. RRWA staff encouraged broader subcommittee participation.
- Ethnic Community Outreach Study
 - Marc Bautista (Rohnert Park) suggested that a new subcommittee be formed to facilitate this project. Marc Bautista, Nazareth Tesfai (SCWA), and Heaven Moore (Santa Rosa) volunteered to steer this effort. The subcommittee will meet on August 11 during the usual TWG timeslot. August is normally a TWG skip-meeting month. RRWA staff will meet with potential subcontractor(s) prior to the August 11 meeting.
- Stormwater Trash Assessment Implementation
 - Heaven Moore update: The copermittee's draft Trash Assessment Work Plan has been submitted to the NCRWQCB for review.
 - Training would be of value for consistent inspections/field visits between the various copermittees. Heaven Moore said there is a checklist at the end of the draft work plan which could be used for training now. Santa Rosa volunteered to take the lead on providing training for staff and will aim for an August date.
 - RRWA staff involvement will begin as the work plan gets implemented. Staff can compile and summarize data for submittal.
- Regional Water Quality Program Development
- Upper Watershed Discharge Characterization Plan
 - Dirk Medema (Healdsburg): GHD is assisting upper watershed agencies with the development of the Discharge Characterization Plan. The Plan is due July 2017 is currently ahead of schedule.
- Lower Watershed Stormwater Quality Monitoring Plan
 - Daria Isupov (RRWA) will provide a draft Monitoring and Reporting Plan for review in August.
 - Brenda Adelmen (RRWPC) asked whether monitoring results will be available to the public. Elizabeth Cargay (Windsor) answers: Yes, after the

Work Plan has been implemented. Monitoring reports will be submitted to the NCRWCB and available online.

- Outreach and Education Program Development
 - Discussion: This effort should be coordinated with other outreach projects.
 The Ethnic Outreach subcommittee will discuss this effort during the August
 9 meeting that is taking place in lieu of the usual TWG meeting.

5. Prop 1 Submittal: Russian River Regional Storm Water Resource Management and Monitoring Plan

- Colleen Hunt (NCRWQCB) update: NCRWQCB will receive full funding (\$200k) in
 the form of State grant in order to assist with regional monitoring program
 governance development. NCRWQCB will contract with the San Francisco
 Estuary Institute's Aquatic Science Center (ASC). ASC will develop outreach to
 stakeholders, work with membership to develop charter, look at short- and longterm funding needs, consider watershed priorities, and develop management
 questions. The draft contract will be made available to RRWA staff and TWG
 members for review and comment.
- Andy Rodgers (RRWA) update on Planning Grant Application: Application was approved and RRWA to receive full funding request of \$500k. Funding will be used for Stormwater Resource Plan (SWRP) development and regional monitoring governance development support. SWRPs are considered a prerequisite for Prop 1 Implementation grants. RRWA should be on schedule to compete for Implementation funding in 2018.
- Dirk Medema requested updated talking points in regards to grant funding. A FAQ sheet and a summary and benefits sheet were created in 2015 by RRWA. These documents will be updated to reflect the current funding realities and made available to the TWG.

6. Forum and Advocacy

- Next lunch meeting with RWQCB staff July 19
 - Heaven Moore requested that RRWA staff ask about a state amendment that would change the definition of sewer to include stormwater drains. This has many implications for MS4s and it would be beneficial to get a regulatory perspective.

- Ann DuBay (SCWA) announced that a draft EIR on Russian River flows will be released for a 60-day comment period. The hearing date is September 13.
- Jenifer Piccinini (Santa Rosa) announced that the Laguna Treatment Plant will
 host a creek week event that includes booths, presentations, and family fun
 activities (including a community mural with paint by numbers). Creek cleanups
 are also planned for Creek Week.

9. Public Comment

- Bob Legge: Russian Riverkeeper has a successful community-based trash awareness and cleanup team. Any community that wants to collaborate with Russian Riverkeeper is welcome to contact him. The team can provide supplies, expertise and has all of the appropriate insurance requirements.
- In response to SCWA's EIR on stream flows, Brenda Adelman commented that lowering minimum stream flows everywhere for an estuary project will negatively affect water quality throughout the watershed.
