3. Stormwater Program

- SB231 passed in Assembly August 31
- CASQA Conference: September 25-27
 - The TWG suggested the CASQA conference be a topic for the October meeting agenda.
- LID Training: October date TBD
 - TWG is aiming to have the LID Training in Fall 2017. As soon as a date is set and Santa Rosa City Hall reserved, RRWA will send out a save-the-date.
 - The focus of the LID Training will be the new manual.
- 2016/2017 Activities Table provided to the TWG on August 29
- Trash Assessment Report Draft 4 submitted for informal review by Colleen Hunt on September 4
 - RRWA sent out the Draft to TWG members on September 1 and will resend the information through SharePoint.
- EPA citizen monitoring quality assurance project plan (QAPP) guide

4. Russian River Storm Water Resources Plan

 - NCRWQCB will continue supporting the extension request.

5. Safe Medicine Disposal

- Sonoma Collaborative meeting August 30 update

 - RRWA draft comment letter was submitted to Board of Supervisors
 - TWG discussed advocating convenience standards for at least one non-law enforcement location for every 20,000 people.
- Discuss sewer ordinance modification
 - SCWA is modifying sewer ordinance indicating it is illegal to dispose of medicines in the toilet which prevents pharmacies from promoting flushing of medicines.
 - RRWA is suggesting Co-Permittees inform wastewater management staff on modifying their ordinance.
- Collectors update
 - Windsor Alliance Medical Center bin was moved to Windsor Police Department on August 31, 2017.
- National Prescription Drug Take Back Day: October 28
