- A. Call to Order and Introductions Board Chair Mark Landman (Cotati) called the meeting to order at 9:05 AM.
- **B.** Approval of the Agenda Mark Landman requested that the Board approve the agenda. The agenda was unanimously approved.
- C. Approval of Standing Items:
 - Minutes: February 25 and April 28 Board of Directors Meetings
 - The Board unanimously approved the minutes from February 25 and April 28 Board of Directors Meetings.

D. Russian River Regional Monitoring Program Funding

- Status of RRWA Proposition 1 Stormwater Planning Grant Application
 - i. RRWA is pleased to announce that they were successful in securing a \$500,000 Storm Water Resources Planning Grant from the State Water

Resources Control Board (State Board) for the project: "Russian River Regional Storm Water Resource Management and Monitoring Plan."

- ii. Andy Rodgers (RRWA) reviewed the scope of the project, including the three main tasks:
 - 1. Project Management;
 - 2. Storm Water Resource Plan (SWRP) for the Russian River; and
 - 3. Russian River Regional Monitoring Plan (R3MP) Governance Development.
- iii. Mark Landman requested that the Board consider authorizing Andy Rodgers to negotiate on behalf of member agencies and assist the City of Ukiah to enter into a contractual agreement with the State in a manner consistent with RRWA mission, goals, and Memorandum of Understanding. Erin Carlstrom (Santa Rosa) moved, and Pam Stafford (Rohnert Park) seconded. There was unanimous approval.
- NCRWQCB application to support governance development
 - i. The NCRWQCB was successful in securing \$200,000 of discretionary funds from the State Board to support R3MP Governance Development.
 - ii. Matt St. John, Executive Director of the NCRWQCB, reviewed the work products of their companion piece to R3MP governance development.

E. Work Plan 2016-2017 Kick Off

- Regional Monitoring Program
 - i. The R3MP will begin in the 2016-2017 work plan year and continue for 24 months.
- Stormwater Program
 - Mark Landman requested that the Board approve RRWA 2016 proclamation of Creek Week and Pollution Prevention Week. Erin Carlstrom (Santa Rosa) moved, and Sean McCaffery (Healdsburg) seconded. There was unanimous approval.
 - ii. CoPermittee Support tasks in the new work plan year will include:
 - 1. Outreach and Education Program Development;
 - 2. Ethnic Community Outreach Study;
 - 3. Trash Assessment Implementation;
 - 4. Upper Watershed Discharge Characterization Plan; and
 - 5. Lower Watershed Stormwater Quality Monitoring Plan.
- Safe Medicine Disposal Program
 - i. The safe medicine disposal program will continue in the new work plan year with the same three-pronged effort:
 - 1. Hauling and Disposal;
 - 2. Coordination and Outreach; and
 - 3. Legislative Support and Advocacy at local, state and federal level.
- Russian River-Friendly Landscape Program
 - i. The Russian River Friendly Landscaping Program is growing this work plan year to include:
 - 1. Event for landscape professionals January 24, 2017; and
 - 2. Development of two new publications: Mini-Guide in Spanish, and a Homeowner Brochure.
- Outreach
 - i. Consider 2016-2017 Video Contest topic:

- 1. The Board discussed various video contest topics, and directed RRWA to move forward with the preferred topic: "Ditch The Plastic, Your Water Is Fantastic."
- 2. Brenda Adelman (RWPCC) made a public comment that this topic should include clear directions that the focus is on reducing one-time-use plastic bottles, not reusable plastic bottles.
- ii. Website and Social Media Campaign
 - 1. Consider Policy for Use of Social Media Sites:
 - a. As directed, RRWA staff solicited third party review of the draft Policy for Use of Social Media Sites (Policy), and the Board was provided a hard copy of the changes.
 - Mark Landman requested that the Board approve the Policy.
 Pam Stafford moved, and Shaun McCaffrey seconded. There was unanimous approval.
 - 2. Discussion of banner messaging
 - c. The Board agreed to change "fisheries" to "habitat," so the new RRWA banner message is: "Clean water, habitat restoration and watershed enhancement."
