- **A.** Call to Order and Introductions Board Chair Mark Landman (Cotati) called the meeting to order at 9:05 AM.
- **B. Approval of the Agenda** Pam Stafford moved that the Board approve the agenda. Marc Landman abstained. The agenda was approved.
- C. Approval of Standing Items
 - a. Minutes: February 23 Board of Directors Meeting
- **D. Presentation of Video Contest Awards:** "Ditch the Plastic Your Water Is Fantastic!" Kory Hebner, Sonoma County Water Agency
 - a. Kory Hebner presented this item and Mark Landman presented the awards. Congratulations to the winners of the 14th annual Student Video Contest:

E. Board of Director Business

- a. Andy Rodgers reported that the quarterly next Lunch meeting with NCRWQCB is scheduled for May 4.
- b. North Coast Resources Partnership (NCRP) Policy Review Panel and Technical Peer Review Committee meeting was on April 20, and the NCRP Integrated Strategies meeting was on April 21. Andy reported that The California Department of Water Resources released the "Stakeholder Perspectives - Recommendations for Sustaining and Strengthening Regional Water Management" report, which is based on extensive input from integrated regional water management practitioners and stakeholders.
- c. Andy Rodgers announced that Mark Landman, Mark Milan and Andy Rodgers would be presenting to the Water Board on May 18 on RRWA recent accomplishments and upcoming projects.
- d. Andy Rodgers reported that the newly launched Sonoma County Venture Conservation Phase 1: Regional Conservation Partnership Program (RCPP) has two specific goals: Shared, proactive and positive vision for conservation of working and natural lands; and Resilience of agricultural and natural systems to drought and climate change. There are 15 partners responsible for providing the match to the RCPP grant. The Watershed Association is providing \$2,000 per year over five years for a total of \$10,000 of in-kind services as Match.
 - Lynda Hopkins asked if WDR's were a driver for the planning projects. Andy responded the project will assist with WDR compliance.
- e. The board discussed experience and outcomes of the successful March 24 Russian River Confluence meeting. Melanie Bagby suggested having a Spanish voice over for the confluence film that was presented.

F. RRWA Project Updates

- a. Andy Rodgers reported on the status of the following work plan projects.
 - i. The Laguna Mark West Monitoring and Reporting Work Plan is being finalized with the water board.
 - ii. The Trash and Litter Assessment Report final draft is being prepared by the members and RRWA.
 - iii. The Ethnic Community Outreach Work Plan is being finalized by RRWA and a TWG subcommittee.
 - iv. The City of Santa Rosa hosted a LID training for member agencies on April 3 and a LID training for the development community on April 24. RRWA anticipates another training will be scheduled for late summer or early fall 2017.
- b. Andy Rodgers reported on the status of the Safe Medicine Disposal Program
 - i. A few program sites in Sonoma County have changed to a new medical waste hauler, and can now accept controlled substances. The City of Santa Rosa developed updated signage to be installed on bins serviced by Assured Waste Solutions. RRWA's operations subcommittee is developing outreach communication strategies for the expanded service.
 - ii. A DEA Takeback event is scheduled for April 29.

- iii. Mark Landman suggested the board prepare a letter to the County recommending convenience standards be refined to require at least one non-law enforcement collection location to be provided in every community. The board agreed and directed RRWA staff to prepare a draft letter for review. Dan Hamburg requested Mendocino County be included in letter.
- c. Andy Rodgers reported on the status of Outreach
 - i. Environmental Column authors for May, June, and July confirmed!
 - ii. Andy Rodgers reported on RRWA's Facebook, Instagram, and YouTube channels, launched in August 2016 with the goals of increasing <u>awareness</u> of RRWA and <u>traffic</u> on the RRWA website. The number one viewed RRWA webpage is the Homepage. The number one source of website traffic is Facebook. Additional website and social media outreach performance Metrics were reported on, including highest reaching post, followers and ad campaigns.

G. Russian River Stormwater Resources Management and Monitoring Plan

- a. The Prop 1 Stormwater Resource Plan's (SWRP) kickoff meeting took place on February 2. Andy Rodgers provided an overview of the SWRP Planning Grant: Benefits of the Regional Approach, Roles and Responsibilities, Sections of the SWRP Projects that can be Included, and Project Criteria. The SWRP schedule, next steps and ways to get involved were also covered. There is a SWRP project information page on the RRWA website.
- b. There is coordination of the SWRP with Russian River Regional Monitoring Program (R3MP); San Francisco Estuary Institute (SFEI) is facilitating the R3MP development. The kickoff meeting for the R3MP was held on March 8. The suggested next steps are to establish a Steering Committee.
