- **A. Call to Order and Introductions** Board Chair Mark Millan (Windsor) called the meeting to order at 9:00 AM.
- **B.** Approval of the Agenda Mark Millan asked if there were any changes to the agenda. No changes were suggested.

#### C. Approval of Standing Items

- Minutes: December 18, 2017 Board of Directors (BOD) Meeting
  - The Board unanimously approved the minutes from the December 18 BOD Meeting.
- D. Guest Presentation: Jeremiah Puget, NCRWQCB, Constituents of Emerging Concern-Current Regulatory Framework and Results on the Russian River Watershed Pilot Study
  - Jeremiah Puget (NCRWQCB) gave a presentation on the Constituents of Emerging Concern (CEC), Current Regulatory Framework and Results on the Russian River Watershed Pilot Study. The Russian River Watershed Pilot Study is the effort to encourage a watershed based planning, regulatory, governance and finance system.

- The study focused on endocrine disrupting constituents, including plastics, microscrubs, and estrogen compounds. The study targeted whether the CEC was present in effluent or stormwater runoff, and to what extent using targeted chemistry, bioanalytics and bioassessments. Cell assays provided reliable and integrated measures of chemicals to show CECs in the Russian River watershed present a low to moderate concern in the river.
  - Mark Millan suggested it would be good to relook at potential contaminants and see if they would need to be regulated.
- The second analysis was on fish and how flame retardants (PBDE) may be present in fish tissue. The highest PBDE would show in the highest lipid compounds of fish due to bioaccumulation. Flame retardants aren't a factor in the Russian River since their concentrations in fish tissue were low, but it is recommended to recognize flame retardants effects on future wildlife.
- The third analysis was on pesticide use which found the largest number of detections in mixed use agriculture and urban sites. Six pesticides were detected including bifenthrin, fungicides, and legacy insecticides. Pesticides in water were low in concentrations with fungicides being the most abundant but not highly toxic. The study found that agricultural runoff is not a likely major concern during the fall season based on the study, while urban insecticides are currently exceeding or approaching levels of concern.
- Jeremiah's take-away message to the BOD was in support of the blue-ribbon panel screening process which allowed a new method of analysis using bioanalytical tools. Although concentrations were low, it would be best to monitor these potential contaminants. RRWA also has contributed greatly by supporting the Safe Medicine Disposal Program to help keep potential CECs out of the Russian River.
- Mark Millan suggests getting someone from the State Water Board to be a guest presenter.

- Joe Naujokas asked what it would cost to add a sampling site to the study. Jeremiah said he would inquire and get back to RRWA staff with information.
