2. Presentation: Ryan Pedrotti, Sonoma Water's Water Education Program

• Expanding the program beyond the current service area

Ryan provided an overview of Sonoma Water's Water Education Program for member agencies not currently serviced by the program. The presentation has been incorporated into these notes. The cost for participating is \$50,000, to be divided by the County of Sonoma, Healdsburg, Sebastopol, Cloverdale, and Ukiah.

RRWA to set up a special TWG meeting for January 8 to discuss the workplan and Caltrans.

- C.1.B. Notify Colleen (RRWA) if members want to opt into C.1.B. for additional support with collaborative outreach.
- C.1.D. Public Effectiveness Assessment-Does the group want to hire a company like Data Instincts to conduct an outreach survey. Ann (Sonoma Water) polls people every other year. Do other agencies do that? Can existing surveys support this effort? Nick (Santa Rosa)-get a quote from Data Instincts. Elizabeth (Windsor)- include three survey components.
- C.2.A- for Santa Rosa, change to be more general support and reduce the level of effort by \$10,000. Cotati is going to determine continued need for this project.

- C.2.B. Increase level of effort to include graphing and trends analysis. Remove upper watershed agencies from this project.
- C.3.A. Santa Rosa requested this project be removed.
- C.6.A. TWG requested this project be removed.
- C.7.A. Agencies wanting to participate need to let Colleen (RRWA) know.
- C.8.A Remove Santa Rosa and Sonoma Water from special benefit project. Windsor will likely want to increase the level of effort.
- C.9. Santa Rosa would like to fold into a regional contract and reduce the number of facilities. Nick (Santa Rosa) will get back to Colleen (RRWA) with direction for moving forward.
- C.14 Santa Rosa would like a budget for 1,000 grease scrappers.

TWG is requesting adding a project for a new outreach branding campaign. This would include budget for bulk purchasing.
