# 2. Co-Permittee Meeting Updates

Nick (Santa Rosa) is now leading the meetings with the Town of Windsor taking notes.

Elizabeth (Windsor) reported that they are starting to review their new permit. They have finalized the data valuation on the permit monitoring and reporting program. The report is being sent to the Water Board this week. Phase 3 of Streets to Creeks will begin in September and extend through December 2021. Everyone is working on their annual reports. Construction Storm Water training for maintenance staff is coming up, tentatively early December. The drought is affecting LID and Heaven is going to talk to the State about watering and maintaining these landscapes. The Laguna Monitoring Program went out for public comment; None received. They are expecting the Water Board to provide them with a letter indicating that they do not need to do dry weather monitoring.

Vanessa (RRWA) asked if there was value in RRWA staff participating in the meetings since Oriana (County of Sonoma) is the Co-chair of the Phase 2 Subcommittee. Oriana mentioned there is a construction subcommittee that may be of interest. Vanessa let the group know there are many subcommittees, such as the Public Information Subcommittee. What, if any, subcommittee would bring value to the group for RRWA staff to participate in?

Oriana (County of Sonoma) is moving to the City of Sonoma. Eric (Cloverdale) would like RRWA to stay on the Phase 2 Subcommittee. Elizabeth (Windsor) asked if participating in subcommittee is in budget; Vanessa confirmed it is.

**Action:** The group directed RRWA to participate in the Public Information subcommittee.

#### 8. Items of Interest

June 25, 2021, the State Water Resources Control Board issued a Public Notice announcing a 60-day public comment period for the draft Statewide Municipal Stormwater Permit and draft Time Schedule Order for the California Department of Transportation (Caltrans);

- July 9, 2021—A Public Workshop providing a staff overview of the draft permit documents, and the opportunity for interested parties to ask questions and provide informal feedback.
- July 20, 2021— A State Water Board Public Hearing allowing interested parties the opportunity to provide oral comments directly to the Board; and
- August 27, 2021—The public comments due date at noon, for written public comments regarding the draft permit and draft time schedule order to be submitted to the Board.
