Serving as Executive Director for the Russian River Watershed Association (RRWA), I'm writing to express my support of the application submitted by the Town of Windsor for the 101 Underpass and Old Redwood Highway

Corridor Improvements Project. The project proposed by the Town involves litter abatement, beautification through three separate public art installations, and clean up and maintenance of the riparian areas along Windsor Creek and East Windsor Creek.

The RRWA is a coalition of ten public agencies in Sonoma and Mendocino Counties that have come together to coordinate regional programs in the Russian River watershed for clean water, habitat restoration, and watershed enhancement.

The Russian River watershed consists of over 150 creeks that provide water supply, wildlife habitat, flood capacity, and recreation. Unfortunately, trash and debris accumulation in local waterways impair water quality, wildlife habitat, and, at times, recreation and flood capacity. Additionally, overgrown foliage on creek and riverbanks act as a "catch-all" for accumulation of blowing trash. The proposed project will trim overgrown bushes, plants and trees to remove the "catch-all" factor, while involving members of the community to clean up litter in the watershed area, as well as the 101/Old Redwood Highway underpass vicinity.

The Town of Windsor has planned two separate community clean-up events – Earth Day in April and Creek Week in September. The Russian River Watershed Association sponsors multiple watershed clean up opportunities throughout the year, including Creek Week, the fourth week in September. A Clean California grant award would help fund the equipment and supplies necessary to ensure the preservation and protection of our watershed resources, while beautifying the Town of Windsor, thereby creating a cleaner and more pleasant experience for pedestrians and motorists alike.
