Elizabeth (Windsor), Claire (Santa Rosa) went for the Caltrans grant and didn't get it. Recommended working regionally and with bigger group. Adriane (RR Confluence) also went for the grant, but it was a difficult application that would have taken a team to prepare. Claire confirmed that the City of Santa Rosa didn't coordinate regionally, but they had a variety of internal departments coordinate.

### 3. Technical Working Group Business

Trash capture collaboration

The co-permittees indicated there may be a potential interim order from the regional board to address trash capture while they work on the permit renewal.

- Windsor is monitoring a couple times a vear
  - Waiting for update to workplan
  - Looking to do pilot project to try 3 types of trash capture but got cut from the budget
- Santa Rosa waiting to see what's going to be in permit
  - As of January 1, Zero Food Waste Ordinance. Nick (Santa Rosa) is tracking any behavior changes.
- o Consensus from members is that they are waiting to see what happens with the permit.
- Composting collaboration (SB1382)
  - Zero Waste and the RRFL Subcommittee Couple of fliers for carbon gardening and composting are available; reach out to Sandy (RRWA) for more information
  - Vanessa (RRWA) made note that Mendocino recently joined the subcommittee and asked for more participation in the subcommittee
- 2022/2023 Environmental Article sign ups
  - Add topics on a rolling basis to keep all municipalities updated about what topics are fair game

- Fiscal Year 22/23 Environmental Article sign-ups
   Elizabeth (Windsor) requested that staff provide a list of all the years topics to the author reminder, so they know what topics have been covered recently.
   Author commitments for FY2022-23 will be solidified at the May meeting.
   Elizabeth (Windsor) will trade RRWA's April assignment for their February assignment.
- Consider repurpose of Steelhead Festival funds
  - o Considering repurposing \$1,000 Steelhead Festival donation
    - TWG is in support of providing \$500 sponsorship to Earth Day for Mendocino County
    - Vanessa mentioned RRWA could potentially repurpose additional funds
    - Elizabeth (Windsor) mentioned Badass Coffee is giving away large coffee bags that could be used for litter picking. She is also in support of RRWA using additional sponsorship funds to purchase litter pickers that Windsor can store for anyone's use.
  - o TWG direction for RRWA to look into:
    - Buying Litter Pickers for collective use after donation to Mendocino Members to reach out to Vanessa (RRWA) about additional sponsorships with leftover funds.

    - Eco-friendly Pest Management
    - Bring in the Pollinators
    - Grow Your Own Salad
    - Drought Proof Gardening (TWG selected)

Vanessa shared recent OWOW social media campaigns and trainings.

- Public Inquiries
  - Fountain Grove Lodge
    - Vanessa asked for TWG direction on if RRWA should provide an informal Zoom presentation for residents. TWG requested RRWA establish what their intent is on having a presentation to determine who is the best speaker; do they want to be members, or do they need resources—It was determined the City of Santa Rosa would be a better contact than RRWA.
  - Black Oak Coffee Roasters is based in Ukiah
    - Asked to partner with a non-profit with focus on watershed health
    - Wants to raise money for watershed
    - TWG suggested they find non-financial partnership opportunities, Streets to Creeks is a good one. Vanessa will reach out to the Coffee business and provide the most appropriate contact (Healdsburg or RR Confluence)
- Co-op for tabling materials
  - Urban Creek Care Guides
  - Pet poop bags (TWG selected)
  - Reusable water bottles (TWG selected)
  - Canvas tote bags (TWG selected)
  - Reusable sandwich bags (TWG also supported)
  - Litter pickers
  - Safety vests
  - o Potentially use excess Steelhead Funds
  - o Coordination with Santa Rosa in the future

Claire (Santa Rosa) is in support of Elizabeth's suggestion and asked if the sponsorship funds can be repurposed for merchandise. RRWA will connect with Nick (Santa Rosa) for sandwich bag order information.
