- **A. Call to Order and Introductions**—Meeting called to order by Vice Chair Hinton at 9:06. Roll call was taken.
- **B.** Consider Emergency Resolution for meeting virtually Director Ford motioned to approve. Director Cruz-Concepcion seconded. None opposed. Motion passed.
- C. Approval of the Agenda—Agenda was approved with no revisions

### D. Approval of Standing Items

a. Minutes: May 26 Board of Directors Meeting—Director Ford moved to approve minutes with the correction of Maureen Mulheren representing County of Mendocino, not City of Ukiah. Director DuBay seconded. Motion to approve the May minutes was approved.

#### E. Guest Presentations:

a. Potter Valley Project (PVP) Updates – Michael Thompson, Sonoma Water

Michael discussed the history, relicensing efforts, PVP surrender process, and current activities.

- PVP has an unknown future with a long FERC process.
- PVP water is critical to the health and economy of the Russian River basin
- A team working to preserve this critical inter-basin water source.
- Russian River water resiliency improvements are needed.
- Without PVP water transfers to the Russian River, in 8 out of 10 years there will not be enough water supply to meet all the needs of businesses, cities, residents, and wildlife that depend on the Russian River

<u>2019 – Two-Basin Partnership formed for relicensing efforts locally.</u> Five partners: County of Humboldt, Sonoma Water, Round Valley Indian Tribe, California Trout, and Inland Water & Power Commission of Mendocino County.

- Minimizing or avoiding adverse impacts to water supply reliability, fisheries, water quality, and recreation in the Russian River and Eel River basins.
- Improving fish passage and habitat on the Eel River sufficient to support recovery of native anadromous fish populations, including passage at existing dam locations.
- Collaboration on funding.
- Active participation of tribes and other stakeholders supportive of the Shared Objectives.
- Economic welfare of the Russian River and Eel River basins
- Protecting tribal cultural, economic, and other interests in the Eel and Russian River basins.

#### Current Efforts – DWR Grant

- Investigating acquisition of key components of the Potter Valley
  Project from PG&E and modifying them to function as a water
  diversion-only facility, including estimating the cost of modifications
  and operations.
- Analyzing and developing concepts for the projects necessary to improve water supply reliability in the Russian River under drought and climate change conditions.
- Establish a Russian River Water Users Forum representing water users that are dependent on the inter-basin transfer of water from the Eel to the Russian River through the Potter Valley Project (PVP) to create a source of funding for continuing water transfers. Water Users Forum's focus:
  - Develop a plan for strategic engagement: Collaborate with water user representatives to identify clear goals for the

- engagement process.
- Reach out to and educate stakeholders: The Russian River Water Users Forum will offer a platform for education, outreach, and knowledge sharing to encourage engagement with these issues.
- Facilitate the creation of a leadership structure: Create a self-sustaining leadership structure, such as a steering committee, that is trusted by water users and other stakeholders to represent their various interests.
- Engage in solutions for the Russian River watershed: Assess the likelihood of ongoing financial support for the continued import of Eel River water and for water conservation and supply resiliency projects for the Russian River.

## Questions and comments

Director Garayalde: We put together a water sharing program for the upper Russian river that has been approved by the state water board, the first in the state. She is working with Alexander Valley to form a water district to better manage the water in Alexander Valley and to have a seat at the table while negotiations are going on.

Charlie Schneider: For the Water Users Group, are you planning to have environmental interest be part of it?

Michael Thompson: Yes.

Chris Halle: He is working with Communication and Media professors at SSU for a different aspect of a water related project and they have been interviewing stake holders and creating educational materials and building a social media library. He can connect students to Sonoma Water's effort if that's desirable.

Michael Thompson: Yes. (he will follow up)

Director Cruz-Concepcion: She recommends this presentation be provided to City Councils in the watershed.

Michael Thompson: Yes, he agrees and will follow up.

- b. WATERS Project Chris Halle, Center for Environmental Inquiry, SSU Chris introduced the program he is working on with Dr. Claudia Luke, Director, and Ms. Kerry Wininger, Outreach & Communications Lead. Center for Environmental Inquiry is Education for a changing planet:
  - First-hand understanding of our connection with the environment
  - Skill-building experiences
  - Innovative solutions

The WATERS Collaborative has accomplished

- 233 projects
- 2,749 students (121 courses)
- 20+ partners/yr
- 30 faculty/yr; 15+ departments/yr
- Internships & jobs

Director Alvarez: In your research, what type of liabilities do cities face in regard to porta potties near encampments?

Chris Halle: Some of the feedback has been related to cost and maintenance. There's also been concern about making the encampment more "attractive" for others to come and not leave, or them being used for drug use, which is not always the case. They are looking to dispel some of these misconceptions and misinformation.
