Summary of Interview Findings, Jan 2023

- a. Conducted 38 interviews with a total of 73 individuals, as listed in Appendix
- b. The interviewees represented county and city governments, water providers, agricultural interests, recreation interests, business groups, environmental groups, state and federal regulatory agencies, and resource conservation districts.
- c. A separate process for gathering input from Tribes in Sonoma and Mendocino counties is underway.

Elizabeth Salomone, who is on the project advisory team also provided additional updates: The Tribal briefings and conversations have continued there is a lot of positive feedback regarding the Tribes wanting to be involved. The development of an interim steering committee has started and will be made up of folks that represent a wide spectrum of the stakeholders. She explained that the forum is a watershed wide group that brings voices together to look at opportunities and to talk about improving water resiliency and reliability. State and federal policy will also be of interest for the forum to comment on.
