**2. Guest Presentation: Zero Waste**

Kristen (Zero Waste) provided an overview of Oil Payment Program (OPP). A grant that Zero Waste applies on behalf of all the jurisdictions of Sonoma County. The noncompetitive grant funds are used to implement programs for used oil and oil recycling. Part of the efforts overlap with stormwater as is related to used oil. Some activities by members may be reimbursable by this grant. They have also purchased storm drain labels using grant funds. There is also an opportunity to purchase litter pickers using grant funds from Cal Recycle—they must be purchased through Sonoma County.
